(Getulio Vargas Foundation – FGV Headquarters)



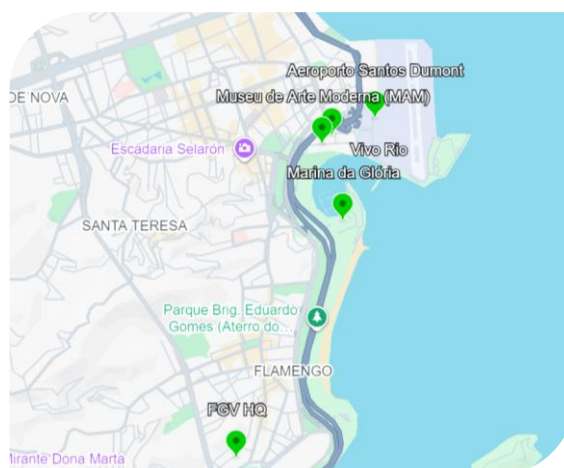
MAM

Museum of Modern Art



The G20 Rio Summit will take place on November 18-19 at the Museum of Modern Art in Rio de Janeiro, known as MAM Rio.

MAM is located in Flamengo Park and offers a striking contrast to the lush green surroundings with its bold modernist architecture. Founded in 1948, MAM has established itself as a beacon of modern and contemporary art, boasting an impressive collection that spans both Brazilian and international works.

General Information

About Brazil & Rio de Janeiro



Weather and Time Zone

Brazil is a tropical country. In November, the average high temperature in Rio de Janeiro is 28°C, while the average low temperature is 22°C. The local time in Rio de Janeiro is GMT-3.

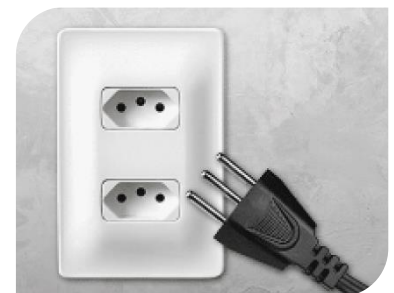


Health Advice and Vaccination

There is no mandatory requirement for proof of vaccination to enter the country. Vaccination or COVID-19 tests are no longer required. The Brazilian Ministry of Health recommends that international travelers update their vaccination status before arriving in Brazil, following the guidelines of the vaccination schedule in their country of origin (particularly concerning vaccines for yellow fever, polio, measles, rubella, diphtheria, and tetanus). The use of insect repellent is advised to prevent mosquito bites and the transmission of dengue, Zika, and other vector-borne diseases.

Voltage and Power Sockets

The electricity voltage in Rio de Janeiro is 120V. **At the IMC all power outlets will supply 220V.** Many Brazilian hotels provide sockets for both 120V and 220V. The sockets in Brazil are type N, featuring a standard 3-pin design. For safety, the sockets are recessed, ensuring that connection and power only occur when the plugs are fully inserted, preventing accidental contact with live parts.

Medical attention



In event venues

- During the IMC's functioning period, there will be medical stations to provide health assistance to press professionals.
- In the event of a medical evacuation, ambulances will be stationed at all event venues, and patients will be transported to their preferred hospitals.
- In the public hospital network, the reference hospital will be Souza Aguiar Municipal Hospital.

Health assistance elsewhere in Rio de Janeiro

- In the event that a G20 participant experiences a health-related issue in other locations, it is recommended that they contact the emergency medical services helpline, 192, to request the assistance of the SAMU (Urgent Mobile Attention Service).
- The SAMU 192 service is provided free of charge and operates on a 24-hour basis to respond to medical emergency cases. The system has several ambulance bases throughout the city, to optimize response times.

Visa-Related Information



Depending on their nationality, some journalists may require a visit visa to enter Brazil. Foreign press professionals must verify visa requirements with Brazilian embassies and consulates abroad. Entering Brazil

Temporary Admission of Press Equipment



The Brazilian Federal Revenue Secretariat regulates the procedure for the temporary admission of press equipment into the country.

1. For equipment belonging to private press professionals arriving in Brazil on commercial flights, the declaration must be made individually using the e-DBV electronic form, which can be completed prior to arrival in Brazil. The form is accessible at e-DBV Form:

2. Equipment belonging to members of the official press and private press professionals arriving in Brazil on official flights must be declared on a printed form, which must be sent to security@g20.gov.br, with a copy to the respective Liaison Officer. Each delegation should submit a single form listing all goods to be temporarily admitted. The form is available at the following link:

Accreditation

Media Badge Pickup



- Due to security considerations and space constraints at the International Media Center (Vivo Rio), the number of press badges issued will be limited. The aim is to accommodate the widest possible range of media outlets within the venue's capacity.
- Permanent press badges issued by the Presidency of the Federal Republic or the Ministry of Foreign Affairs of Brazil will not be accepted.
- Please note that submitting an accreditation request does not guarantee the approval of a press badge.
- Media personnel must present a photo ID (passport, ID card, or driver's license) to collect their badges. Badges can also be collected by a representative of the outlet, provided they carry an authorization letter, a photo ID, and a list of the accredited media personnel from the outlet.
- Official media badges will be distributed by Liaison Officers, along with the delegation badges.
- Media personnel arriving in Rio de Janeiro after the credential distribution has ended may, as an exception, collect their credentials at the Getulio Vargas Foundation Library (FGV) before boarding the Press Shuttle.
- It is important to note that media representatives who collect their badges on 18 and 19 November may experience delays and might not reach the International Media Center at their desired time.

Access

- Access to the IMC is restricted to accredited media personnel.
- Please note that on-site registration will not be available. Accredited official media and delegates will also have access to the IMC.
- Direct access to the IMC for accredited media personnel will not be permitted; entry will be facilitated exclusively through the designated Summit shuttles.
- To access the IMC, all accredited media personnel must assemble at the Library of the Fundação Getulio Vargas (FGV), located at Praia de Botafogo, 186, via the Barão de Itambí Street – Botafogo.

Major Facilities



- Approximately 1000 workstations will be available for accredited media personnel at the IMC, allocated on a first-come, first-served basis. Most workstations are equipped with LAN ports for reliable connectivity
- Printers
- High-speed Wi-Fi
- Media booths (approximately 15.5 m² in size), limited in number and allocated on a first-come, first-served basis
- Three media briefing halls, each with a capacity of 40 people, available exclusively for booking by official delegations
- Indoor and outdoor live stand-up positions, available on a first-come, first-served basis, equipped with power outlets and LAN ports
- Live streaming of selected segments of the summit
- Media lounges
- Help desk
- Medical room
- Food and beverage counters

IMPORTANT:

All electrical outlets at the IMC supply 220V.

IMC

Shuttle Service



- A regular shuttle service will operate between FGV and Vivo Rio every 20 minutes, according to the following approximate schedule:
 - **Sunday, 17 November**
from 13:50 to 20:45
 - **Monday, 18 November**
from 05:50 to 07:40 / from 10:30 to 19:30 /
from 21:00 to 23:45
 - **Tuesday, 19 November**
from 05:50 to 07:40 / from 10:30 to 14:30 / from
17:00 to 23:45
- The non-operational periods on November 18 and 19 refer to the planned movements of Heads of State, Heads of Government, and Heads of International Organizations. During these movements, the transportation system between FGV and Vivo Rio will be suspended.
- To use the shuttle service, media personnel must present their Summit accreditation badge along with a photo ID.
- Media representatives and their equipment will be subject to security screening prior to entering the IMC.

IMC

Media Guidelines



- Accredited media will have access only to the IMC.
- Media representatives are required to keep their badges visible at all times during the event. Entry or remaining in the venue without a badge will not be permitted.
- Access to the Museum of Modern Art (MAM Rio), the main Summit venue, will be restricted to select members of the media. Official programs such as arrivals and departures will be covered exclusively by official media. Opening speeches and specific press conferences will be covered by a designated media pool.
- The G20-EBC TV (host broadcaster) will provide a video feed of selected parts of the Summit to accredited media via national satellite. For more information, see the **Official Signal** section of this manual.
- In addition to the live broadcasts, videos, photos, and audio from G20 Brazil will be available for download at www.g20.org, in the press area.
- As a courtesy, food and beverages will be available for the accredited Media during the operational period of the IMC.
- **Drone filming will not be allowed under any circumstances**, and any equipment may be shot down.

IMC

Media Briefing Rooms



- There are **03 (three) media briefing rooms** available at the IMC, each with a capacity of approximately **40 people**.
- The media briefing rooms are available exclusively for booking by official delegations on a first-come, first-served basis.
- Reservations for the rooms can be made once the IMC begins its operations on **17 November**. Each delegation's press focal point should coordinate the booking with their G20 Rio Summit press focal point.
